Community Coalition: Need a representative from each of 12 sectors. We would also love more native prosserite representation and participation. Being a member involves coming to most meetings and participating in a subcommittee, trainings, and some volunteer events.

Hidden in Plain Sight: This program is a bedroom set up at any given location and items in the bedroom are hidden that indicate problem behavior. We then deliver a presentation that shoes what they are and how they relate. Resources can be set up at presentation as well.

Trainings

CADCA: Feb 4-9, 2-4 people go to WA DC to receive education and to meet with policy makers. Mid-year is in July group of 10 youth and 5 adults to Orlando for workshops and training to bring back to the coalition and community.

GGC Facilitator Training: 3 day training, best if a parent yourself. Must commit to deliver 1 training with in a year of being trained.

Tobacco Prevention Program Training: Learn Sally the Skunk program and help organize implementation.

Youth 2 Youth: 2 day out of state training to develop skills working with youth. Must commit to 6 youth events this year.

Prevention Summit: Every year in Yakima Nov 2-4 this year, must sign up by September 30.

Resilience Training: October 12 screening of "resilience" at Bethel. Oct 13 day conference at Prosser High. Also need volunteers or set up and take down.

Direct Services

LGBTQ Outreach: Support local GSA, Suicide prevention walk on September 30th at Outback on Canal in Kennewick. Will provide a buss for communities members to travel on.

Second Steps: Middle School PE teachers deliver as part of health curriculum. How can we expand parent knowledge, awareness and involvement?

Mustang CIA: Youth coalitions at High School and Middle School. Meet twice a month. Need adult volunteers to help with After Prom Party in the Spring. What other programs do you want to see students working on?

Guiding Good Choices (GGC): Program for those who parent. Offered twice a year in English and Spanish. 5 sessions over 5 weeks. Discusses family bonding and communication as a protective factor to reduce youth involvement in risky behavior.

Communities In Schools (CIS): Social work position focusing on increasing attendance to promote academic achievement. Works with students and families to find resources for basic needs.

Elementary Outreach: Sally Skunk program for middle schoolers to teach elementary schoolers prevention curriculum. How when and where to implement?

Lets Draw the Line: Localized youth media campaign. Need to revamp this year with fresh faces.

Talk they hear you: localized adult media campaign. Need help switching out posters quarterly, how to get video seen and circulating.

Alcohol/Pot Policy: Sticker shock reminds consumers the consequences of providing to minors. Need help stickering near spring break. Also need help with after prom party.

Access Team: This project is reaching out local alcohol and pot retailers to ask them to put on underage restrictions to their social media. We need people to reach out to retailers, explain "how to" and we can help. Are there other ideas to access restriction we should be addressing?

Take Back Program: We have take back programs in Prosser, Richland and Kennewick. Need to spread the word and to give out more personal lockboxes.
