Conclusions	<p>Strategic plan is extremely detailed. It is due March 30th. Prescription take back program: How we want to deliver it, once or twice, do we want to do it with another event that goes on in town, who wants to coordinate it. Senior center could be a place where we could have a drop off, or city hall. We can do it for a week long or two days, just depends on how long we want to do it. The local pharmacy may have an option for a take back. A take back program cost about \$3,000. Tracy suggested that we try it just one time our first year to see how big of a success it is. Rachel said it would make more sense to have the take back program at the pharmacy or even the hospital.</p> <p>ADVERTISING:</p> <p>We can put it in the city newsletter, put it in the newspaper, and print our fliers to put in businesses. Fliers to be handed out at the pharmacy, and we can also post about it in the church bulletins. Post it on our Facebook page and have coalition members share it on their status. May was the suggested month to have the take back program.</p>

Discussion	Programs at school for parents, partner with places about parenting programs.		
Conclusions	<p>There are a few programs for parents to participate in. For example, Parenting Wisely is a program that we have access to. We can open the school one evening of the week so that parents have access to the online program. It is available in English and Spanish. We would need adults to volunteer to help out at the family management programs. Grace Fellowship has an unwed-mom program/support group. We have no men and women programs in Prosser. So we could piggyback with another group, or we could do our own thing. If we say we offer a program, we have to have a minimum and maximum number of participants. We have to track attendance and give pre and post tests to track progress to see if it is making an impact.</p>

Discussion	Offering prevention programs at the Middle School and high school
Conclusions	<p>We can have up to 40 participants. Jen will be meeting with the elementary school principals with Ray T. The teachers do need training - it is a district wide program. It is a program that is in place for early prevention/intervention. Pre/post tests will be needed, and attendance needs to be tracked. The teachers would add this curriculum into what they are teaching already, and they would be doing it for six months. This program is K-5 only. Kayla mentioned that if she could teach this curriculum to the elementary kids to take the load off the teachers, and it is also allowing the kids to get to know Kayla so that they know her when they're in high school. Even to just have the teachers trained on it would be great.</p>
