Current Business

1. Approval of Minutes
 - a. **Motion to approve September membership minutes without amendments**
 - i. Motion made by Chris Cisneros, seconded by Jesalyn Cole, unanimous approval
2. Treasurer's report - Haley Greene
 - a. CPWI spending xxx, DFC spending xxx. DFC spending was higher than typical but fiscal year is coming to a close so we purchased media campaign supplies. HIDTA spending was xxx.

 1. City is opening back up to the public
 - ii. Deanna Flores – Prosser School District
 1. Kindergarten has moved back into the Keene Riverview building.
 2. Both Keene Riverview and Prosser Heights are slated to be complete with construction by August 1
 3. Schools are currently dealing with residual mental health struggles.
 4. Eight students are currently remote learning at the elementary level, nine in the middle school, and 20 students are remote learning at the high school.
 5. District is now providing after school tutoring
 6. School is seeing mental health issues becoming more prevalent
 - iii. Lupe Maldonado – Migrant PAC
 1. Students are behind and are playing catch up
 2. Migrant department is starting interventions after school

3. First PAC meeting coming up
 - a. Will be hosting a booster clinic – open to the public
- iv. William Waters
 1. Tyler Bentley is a new psychologist working in the school district
- v. Heather Morse – PMH
 1. When school began, she noticed a drop in referral rate to her, but now referrals are on the rise
- vi. Briseida Chavez – UFW
 1. October 29th PAC meeting will have Pfizer, and J&J vaccines available, warm clothing.
 2. Sunnyside will be hosting a Thanksgiving food drive in November
- vii. Chris Cisneros – Boys and Girls Club

DEA Public Safety Alert - Chief Giles

1. Local impact – described changes in recent legislation regarding reasonable suspicion vs. probable cause

3. Youth is mostly using marijuana
4. Adult drug use is mostly meth, and can be laced with fentanyl
